## 1. Guests

- a. Meg Parish (CDPHE) State updates
  - i. Amy Konowal Interim Clean Water Program Manager
    - **1 COVID-19-** Not much different than before. CDPHE continues to be remote.
    - 2 Staffing Nicole Rowan is the new Director and may come back to CWWUC meetings in the near future.
      - a Clean Water Program Manager should be filled by the end of the year
    - 3 Regulation and Policy Updates -
      - The Water Quality Roadmap efforts are shifting to November 18<sup>th</sup> to lakes nutrient criteria development at next meeting on November 18<sup>th</sup>.
      - Voluntary Incentive Program They are working on a marked-up policy. It will not be changed significantly but will likely have some clarification. Will be getting it out before the November meeting.
      - c Workgroups coming up
        - i MS4 issues, Reg 84,
        - ii Permits webinar on October 14<sup>th</sup> is on Water Quality Planning targets and what has been learned and how it intersects with chemical evaluations. They will discuss how limit scope PELs might be appropriate for chemical approvals. They are also going to be talking about nutrient criteria to alleviate small system concerns.

  - WOTUS Foundational rule making followed by a second rule making is expected. They are holding listening sessions that the
  - **2** 401 water quality certification there is no new information.
  - **3** Infrastructure bill is moving forward.
  - 4 EPA will issue a PFAS roadmap this fall
  - Groundwater and hydrologic connection – Colorado have been looking at connection between

hydrologic connection between ground and surface water.

- 6 EPA There is a strategic action plan put out on harmful algal blooms that include an event tracking and monitoring program. There is a report that provides support for state development of nutrient standards.

**d** Permit Mods for PFAS may go into effect in the first of the year. Delayed due to two comments that were not addressed.

- c. Gabe Racz Updates and discussion
  - i. PFAS responsive comments and status report They intend to issue final permit modifications at the end of November
    - 1 There were two responsive comments they missed the first time around and Gabe does not feel it is important to submit responsive comments on those.
    - 2 Next steps for the Councils is to review the final permits and if there are questions bring those to the meeting in December.
  - ii. NIL's workgroup update For anyone with a discharge to a reviewable stream.
    - 1 The background is that in permit renewals the Divisions practice is to start over again and come to a decision which may be different than their previous determinations on antidegradation.

- Workgroup is on implicit NILs The first step of antidegradation review is to determine if a permit renewal will allow an increased water quality impact. If you had a permit limit, then simple. If not, then effluent data used to determine if the parameter was in your effluent to determine concentration and load. If it is determined that the load and concentration will not cause increased impact, they will not change the permit. The problem is there is often not enough data to provide good information. If there is not enough data then you don't get a NIL you go straight into anti-degradation review.
  - **a** Next step the Division will provide guidance memo for comment.
