

Draft Meeting Minutes Wednesday, June 14th, 2023

Blair got the meeting going and Amy recorded it <u>here</u>. Blair welcomed everyone and went over the agenda.

Nathan Moore, CDPHE staff – Blair asked about progress on the Chemical Evaluation forms. Water Quality Control Division (WQCD) staff met with John Gage and Nicole Poncelet Johnson. They're still digesting the concerns. They'll need some more time to work through the issues. They were considering a permits webinar that would include the Chemical Evaluation Forms.

Nathan discussed the Coors permit process. There was a third-party request to modify their permit. The concern was that Coors wasn't notified until the change went out for public comment. He clarified that it is their process. He added that they had let Coors know that their permit was posted for public comment.

He reported on the Sackett decision on Waters of the United States (WOTUS). The WQCD posted a proposed policy. They are looking to move as quickly as possible. In the meantime, the Army Corps of Engineers (ACE) has put a hold on issuing dredge and fill permits. The ACE will need to determine how to incorporate the ruling into their procedures. There are likely to be future cases before the Supreme Court. Blair asked how big the decision is for Colorado. It doesn't impact discharge permits much but it does impact dredge and fill permits.

Gabe asked if Nathan had heard about any proposed changes to water quality standard setting and NPDES procedures regarding Colorado issued permits. If the scope of WOTUS is further constrained, how would Colorado's programs to protect water quality be impacted. Nathan said we'll have to wait and see.

The Water Quality (WQ) Forum is coming up. The retreat is in July in Denver at the SPUR campus. Many stakeholder efforts will be discussed at the forum: http://colowqforum.com/cleanWater/annual-retreat/. Dan asked about the Reg. 22 work group. The work of the group has been moving slowly but there is interest in continuing the program, in spite of Bret Icenogle's departure from the WQCD.

Andrew added that the Chemical Evaluation Forms will be discussed at the August webinar. People can email him if they have any specific questions.

Link Muller, Metro Water Recovery – A presentation on Metro's cooling towers at their Northern Treatment Plant was made by Link Muller. The Northern Treatment Plant has tertiary treatment. Temperature standards were adopted in 2007 to protect aquatic life. Plant staff record effluent temperatures. December is the month when they need cooling. CDM Smith conducted an Alternatives Study. The best alternative was determined to be the cooling tower. The concept is similar to air conditioning units but isn't self-contained. There aren't a lot of design criteria to refer to. There could be impacts to Air Quality, Receiving Water Quality and Greenhouse Gases. Other concerns included public perception, icing and noise. The pilot went online January 31, 2023. They immediately encountered icing problems. There are procedures that can be used to defrost the towers. They inspected the media in the towers to determine the amount of scaling/bio material that would accumulate. There were different amounts of bio material accumulation in different media weights. They completed the secondary demonstration in May 2023. They'll begin a tertiary demonstration next winter.

Julie asked them to describe the timing of approval of the pilot process. They had to apply for a site application amendment through Regulation 22. There is a guide in the regulation they followed. It was a little faster than a regular site application, about a month. Blair asked if the temperature requirements at the plant were met. The purpose of the project was to look at the cooling towers operational and maintenance requirements. Achieving the temperature standards was not the goal. Blair was surprised that more material didn't bioaccumulate.

Blair thanked him for the presentation.

Discussion Items

Regulatory Updates – Gabe reported on the Reg. 22 workgroup. It was beginning to work on historical infrastructure having completed some work on construction flexibility. There's a draft memo on how to handle historical infrastructure that hasn't been discussed in depth yet. It would be good for the group to conclude the construction flexibility issues.

Gabe sent out a memo de-briefing the nutrients hearing and potential next steps. There was a Water Quality Roadmap meeting shortly after the nutrient hearing. He shared that there isn't' enough time to complete the items in the road map in the 4 years left. He encouraged members to continue to be active discussing feasibility and implementation before standards development.

The Industrial stormwater permit may have been appealed. There is a lull in Water quality Control Commission (WQCC) hearings in June and July. Blair asked if the CWWUC should add any rationale for consideration at the Water Quality Forum. Gabe suggested the council consider commenting on the scope of the work groups. He suspects that there will be a work group on dredge and fill permits. It will likely impact utilities who use dredge and fill permits to maintain their infrastructure.

The Sackett decision limited where 404, dredge and fill, permits are needed. The state said that if an entity doesn't have a dredge and fill permit, they'll be violating the state clean water act.

Gabe explained that the issue of concern for the CWWUC about the Coors permit modification is that Coors didn't get notification of modification request but did get notification of the draft permit going to comment. There was an abbreviated timeline between when Coors received notification and when the permit was posted for public comment. There will be rulemaking hearings on Reg. 61 and 21. CWWUC could consider proposing that when there is a third party permit modification request that the permittee be notified. It seems strange to modify the permit without receiving any data from the facility.

Budget – Amy, Julie and Katie met to discuss developing a budget for the organization. The potential needs for the council to participate in regulatory hearings requires significant fundraising. The group also talked about the potential for enhanced educational and lobbying efforts. Changes to the by-laws may be required. Gabe suggested that members could partner with the Special Districts Association and/or the Colorado Municipal League to conduct lobbying activities.

Metro's lobbyist is willing to make a presentation. **Amy** will prepare a memo for next month about how much the dues will be increased and how the money will be spent. Meghan weighed in that having funds to better represent the council would be a good idea. Maybe we could investigate options for getting participation from smaller entities.

Stormwater Permits, COR900000 – Gabe reported that the changes to the permit may have impacts. The impacts are not likely to impact the wastewater sector.

Chemical Form Evaluation Subcommittee – John had nothing more to report than Nathan and Andrew already reported. The WQCD doesn't really have the resources to focus on the issue. Maybe the webinar will help.

RMWEA Governmental Affairs Committee —Dan reported that the committee is working to finalize the water quality update. They wrote an article on anti-degradation basics. They might be writing an article about WOTUS. They've had some parallel

discussions about the legislative engagement (lobbying/education) topic. They would be happy to coordinate and help with discussions.

Water Quality Forum Updates – **Meghan Wilson** – Meghan didn't have much more to report than Nathan and Andrew. The Water Quality Roadmap meeting has a capacity limit so register early. The rationale discussion will be robust and will likely include the feasibility work group. There is likely to be discussion around sharing how the recent hearings have gone and how to improve them. The forum will start at 10 am on July 13th.

Drinking Water Council Updates – Cynthia Lane – Cynthia reported that she just returned from the AWWA conference. They spent time presenting on PFAS. The fly in and water week for 2024 will be the same week for water and wastewater. She encouraged people to consider coming. The state revolving fund survey is open through the end of June for water and wastewater. It's really helpful at the state level to get things recorded on the survey in order to get federal funding.

Other — Gabe asked if we want Verity to make a presentation. They're developing greenhouse gas trading markets. It's another piece to the green/grey infrastructure efforts that can generate credit that may be able to be traded. They have some capital they can use. **Gabe** will try to get them to present in August.

Barb shared that we might want a presentation on Denver's re-use water plant permit.

Board Action Items –

Approval of invoices for payment - Jesse moved, Wes seconded approval for payment of all invoices. The vote was unanimous.
